

Tackling the illegal vape market

Context

- Around 1/3 of the UK vape market is comprised of illegal products.¹
- Opinium survey of 6,000 UK adults in May 2024 revealed that 21% were aware of illegal vapes being sold in their area within the past three months.²
- Illegal vapes are unlikely to have been notified to the Medicines and Healthcare products Regulatory Agency (MHRA).³
- Illegal vapes may contain chemicals or levels of chemicals as evidenced by independent laboratory testing, that are not compliant with UK regulations.⁴
- The illegal vape market has been linked to other forms of serious criminality.⁵

Government response

- Trading Standards leads on tackling illegal vapes and through Operation Joseph has seized millions of illegal vapes.⁶
- An additional Government resource of £3 million was provided to Trading Standards in 2023.⁷ Later in 2023, the previous Government also proposed that a further sum of £30 million per year should be provided for law enforcement to tackle illegal tobacco and vaping.⁸
- The Budget in March 2024 announced the planned introduction of excise on vaping products, effective from 1st October 2026.⁹ The excise varies depending on the nicotine strength.
- Proposed introductions of on-the-spot fines alongside existing penalties. ¹⁰

ELFBAR position

- ELFBAR works closely with UK Trading Standards on a case-by-case basis and supports closer cooperation together with law enforcement. The company's UK partner distributor has a primary authority agreement with Kent Trading Standards.
- Trading Standards actions are welcome, but this requires consistent application of resources and investment to tackle this ongoing problem.
- ELFBAR would support the new Government reintroducing at least £30 million per year for law enforcement to tackle illegal tobacco and vaping.
- ELFBAR supports the introduction of excise on vapes, but rates should be proportionate to ensure smokers are not deterred from switching to vaping to guit smoking.
- ELFBAR has acted against more than 230 companies worldwide involved in counterfeit manufacturing, storage, and transportation.¹¹

- ELFBAR's partner distributor is a member of the Anti-Counterfeiting Group (ACG), Association of Convenience Stores (ACS), Scottish Grocers' Federation, Federation of Wholesale Distributors (FWD), Retail NI and Independent British Vape Trade Association (IBVTA).
- ELFBAR is working with the ACS and SGF to report illegal vapes in conjunction with FACT¹² and their partnership with Crimestoppers.
- ELFBAR supports the introduction of a retail licensing scheme that would also provide a structure or system for checking licensed retailers.
